New Business

- AGR has contacted me regarding their lighting met with them last Thursday currently reaching out to
 property owners backing up on or affected most by the parking lot lighting (Goeller rental, Dan & Krista
 Warren, Gale Warren, Lisa Warren, Frank & Carol Newell, Ann Bleed)
 - ✓ "Goldilocks" issue first lighting choice was too bright; parents now think current lighting solution is too dim.
 - ✓ Also, fraternity seriously considering renting out rooms in the summer to sorority members who need place to stay during the summer, to help defray expenses. This makes them even more sensitive about the lighting.
 - ✓ One couple willing to donate cash to pay for security cameras (\$5k+); however, they will not work with current lighting need "whiter" lighting
 - ✓ Original "downward directed" lighting solution now back on the table white, yet directed downward. I have asked them to find the same lighting somewhere else (including consideration of extra 30" of height due to raised piers to avoid cars/pickups backing into them) so that all owners who wish to, can see them at night, to determine if these will work.
 - ✓ AGR folks are VERY invested in having the neighbors be happy; we can all agree that we do not want an incident that could have been preventable, had the lighting been better.
 - ✓ Will keep all posted as to alternatives/decisions made, with input by neighbors
