MINUTES ECCO Board Meeting September 14, 2017 7:00 p.m. New Hope Methodist Church

Call to Order - Paul Johnson

Minutes - January 2017

LPD

Captain Marty Fehringer introduced himself to the group and provided his history and summary of his qualifications.

Neighborhood update:

Officer soon to be added for total of 44 officers. A sergeant was added last year for a total of 8. Discussion of number of teams discussed. The number of teams was proposed to be reduced, but ultimately retained 5 teams. Support from City Council to add further police officers. Average response time is under 10 minutes. Captain Fehringer offered his card and requested that anyone who needs to speak to him feel free to call him.

Rebecca noted concerns about Homecoming Concert, where noise and parking issues arise, in addition to drinking and littering. Captain Fehringer said that he would ensure a couple of officers would be available to monitor the neighborhood.

Fehringer noted 9 buglaries, 28 unlocked vehicle larcenies, 1 locked car larcency. 67 other larceny, mostly shoplifting, bicycles stolen from yards, and packages stolen from porches. One arson in Popeye's bathroom. 6 assaults, 2 were domestic. 5 auto thefts where 4 cars were unlocked with keys inside, the other theft was questionable.

Paul asked if anyone noticed a difference from the lighted crosswalk. Appears that drivers are not influenced by the light as much as was hoped. T. Madsen suggested that an informational article be provided to let drivers know how to respond to the light. Fraternity rep, Josh Pflasterer of AGR, said that the light is making a big difference and that the wait time to cross the street is far shorter.

George Wesselhoft Lincoln Planning Department

Mr. Wesselhoft outlined his experience and background. Offered map handouts (figures XXX and XXX). Proposing to move industrial zoning designations and move to residential or commercial zoning. Industrial zoning allows for uses that may no longer be appropriate for the neighborhood.

Paul wondered if rezoning could encourage revitalization in areas that are in poor shape.

Mr. Wesselhoft affirmed that this would probably occur. Paul asked what we needed to do. Mr. Wesselhoft stated that a letter of support from the community would be helpful.
