## **New Business**

 President presented some recently received information from Lincoln Transportation & Utilites (LTU) about e-scooters and the parking requirements for the scooters. Riders encouraged to park in designated areas, required to take/send picture of scooter neatly parked. Riders can be fined or banned for not following rules.

- Question Scooters left near MoPac Trail & how are they handled.
  - Scooter company phone number should be on scooter
  - LTU may be contacted by phone, UPLNK app or City website
  - Approved riding areas in City are "Geo-Fenced" & scooters have GPS so that company can track vehicle
- Parking Question about what happened to the Permit Parking initiative. Said that it was derailed by Covid.
  - Neighbor said that T-Force freight company will not deliver large freight packages to East Campus neighborhood because they have it marked as a "Student Parking" area. He had to drive to Omaha to pick up item
  - Suggestion that Board take up the Parking Permit project again in upcoming meetings.

### Presentation/question/answer session

• Ed Zimmer – Historic Preservation Planner

President presented short bio of Ed Zimmer's background as historical planner/researcher & author in the Lincoln area, former member of Lincoln School Board

Ed discussed history of the East Campus Area with pictures of early area horse farm & Woods brothers and Henry Luckey as primary home developers of the area. Showed how area was split between Lincoln & University Place until University Place/Bethany were annexed by Lincoln. Omaha, Lincoln & Beatrice (O,L & B) rail line went through the neighborhood to connect Lincoln, Bethany & Havelock with passenger & freight. Discussed & showed photos of some area homes & their history.

## Lincoln Police - Northeast Team - Captain Jeff Bucher

Captain Bucher introduced himself & gave some of his background with LPD. Said one of the biggest LPD problems is recruiting new officers. NE Team area is very large & department is understaffed. New NE Team headquarters to be opened about 1/1/2023 at 52<sup>nd</sup> & R St building shared with LPD dispatchers. Will be looking for substations within the area for officers to work on reports.

- Question What should neighbors be looking for in the area (gangs/gang colors, dress, etc)?. Are neighborhood areas safe?
  - Watch for what looks out of place/gut feeling. Contact LPD if something doesn't look right.
    Walk with friends to feel safer in neighborhood. Be vigilant for problems.
  - Said that Lincoln has a gang problem & is visited by gangs from surrounding area cities. Has 5-6 member gang unit at LPD.
- Question Traffic enforcement in general O St cruisers, speeding/speed traps in neighborhood, parking issues
  - O St is ongoing issue & now mostly in the NE Team area. Other areas of city also have same issue. Difficult to control & usually requires help from NE State Patrol with helicopter that is able to track violators.
  - Retired LPD officer is Parking Enforcement person for the NE Team area. Does a good job & problems should be reported to LPD for handling
  - Speed traps on area streets are occasionally set up, but other types of area problems are a higher priority with limited staff.
