LPD Report - Captain Jeff Bucher

- 29 vape shops in NE Quadrant. Recent "sting" had 50% of them selling to underage children comment from Board invitee group, who is a counselor @ LHS, and indicated that vaping is going on "all day long" at the school.
- KIA, Hyundai thefts continue up 80% over last month 18 vehicles out of total stolen since January 1 have not yet been not recovered.
 - ✓ Most perpetrators are 13-16 years old a large concentration lately in East Campus area 15-year-old arrested @ 33rd & Holdrege it was his 4th arrest.
 - Chases not the protocol in the city limits due to potential liability there are now 3 TFOs (Tactical Flight Officers) State Patrol helicopters helping LPD in safely pursuing perpetrators.
- Larceny from autos continues.
- NE Quadrant personnel changes are occurring- Captain Bucher will now lead Investigations our new Captain will be Max Hubka.
- Bucher commented that the Clinton association is a strong group and suggested that we partner with them when possible on
- similar issues affecting both associations.
 - ✓ Gloria Eddens is the President; her husband also serves on their Board
 - "The Tiny Village" issue came up building "tiny homes" transitioning inmates post-prison using donated materials & contractors. These transition homes are planned for the open area on the east side of 27th across from Matt Talbot Kitchen (gifted from the City).
