Several organizations will be available to provide information about winterization program, AGR fraternity building replacement and other topics. Pay your annual dues, sign-up for electronic notification.




7:00 pm ECCO business meeting

ECCO Board Nominations: Will You Serve?

This year's ECCO board has discussed this issue and has decided to try to institutionalize the board's stability and sustainability with some changes to the by-laws.

The board believes there needs to be a plan for ECCO board terms of

service and turnover. People will be elected to the board for a term of 3 years. Each year a third of the board will be leaving to let others serve and two thirds will remain on the board for continuity. The board will be comprised of nine to twelve people. Board members whose terms of service are up may be elected again if they are nominated and chose to serve.

We would also like the ECCO board to have representation from the entire neighborhood. It would be great to have board members from each of our quadrants, if you think of 40th St and the MoPac Trail as the lines creating quadrants. This will take the next few years to accomplish as the current board membership cycles through our three year terms. As people are nominated for the board and the membership elects the next group, I would like this idea to be kept in mind.

So, ECCO needs you to serve. Please think about serving your neighborhood as a board member of ECCO, if not this year, sometime in the future. What does your service require?

- Term of service is three years
- Meetings are held monthly for one-two hours on the second Thursday of the month except July
- Depending on your role on the board, time outside meetings may be required
- Sense of community, desire to positively influence the place you live

What do you get? I have gained a better understanding of the neighborhood I live in. I have made new friends. I am honored to serve with a group of talented, committed, knowledgeable people who are also great to know. We have amazing people who live here and by being on the board I have had the opportunity to meet them. I can have an impact.

Free Weatherization Saves Money and Increases Comfort



Helping People. Changing Lives. Weatherization keeps hot and cold air from leaking through a house, helping your home stay warm in the winter and cool in the summer. It prevents both your furnace AND air conditioner from working overtime... which saves you money year-round.

PARTNERSHIP Community Action's Weatherization Program provides free weatherization services to income-eligible Lancaster and Saunders county residents. Priority target populations include seniors, people with disabilities, and families with small children. Both homeowners and renters can benefit

from the program but in the case of rental units, landlords must be willing to follow additional requirements.

Community Action Partnership of Lancaster and Saunders Counties is one of nine programs across the state working in partnership with the Nebraska State Energy Office to save energy through weatherization.

In order to be eligible for Community Action's free Weatherization Program, applicants must meet income guidelines, but they aren't as stringent as for many other assistance programs. For example, a four-person household can earn up to \$44,700 and still qualify for free weatherization. "If home energy improvements won't fit into your budget, this program can provide the investment for you," said Lori Vidlak, Community Action's Weatherization Director. "This investment leads to cost-saving and energy-saving benefits for the home's residents and the local community for years to come. Some homeowners have reported cutting their energy costs almost in half."

Community Action sends trained weatherization inspectors into homes to identify where the biggest energy-savings can be made. "Our inspectors diagnose the causes of energy loss and then prescribe the best treatment option individualized for each home," Vidlak said.

The types of free energy-saving improvements provided will vary with each home but can include furnace cleaning/tune-ups/repairs/replacement, insulation and weather-stripping, door and window repair/replacement, and installation of exhaust fans, low-flow showerheads and CFL bulbs.

Once energy-saving improvements are identified, local weatherization contractors are hired by Community Action to complete the work, helping community businesses thrive while partnering in the weatherization effort. "It's really a winwin for the community," Vidlak said. "The weatherization program saves energy, improves housing stock, reduces utility bills for people on limited incomes, and pumps dollars back into the local economy."




